JOB DESCRIPTION:

This is a responsible medical supervisory position under direction of contract physician. Responsible for overall management of an organized medical unit consisting of RN(Registered Nurses), LVN (Licensed Vocational Nurses), and EMT-P's (Paramedics) on a 24 hour basis delivering consistent and quality healthcare to inmates in the custody of the Sheriff.

EXAMPLES OF TASKS PERFORMED:

- 1. Define, guide and direct the clinical practice of medical staff.
- 2. Management of medical budget, prepare for upcoming year budget and order supplies and equipment.
- 3. Manage Staff supervision, employee scheduling (duty, vacation, and personal leave)
- 4. Review work of staff.
- 5. Maintain, monitor and provide medical protocol per contract physician approval.
- 6. Maintain compliance with Texas Department of Jail Standards.
- 7. Monitor medical unit security in accordance with Office protocol.
- 8. Assist in diversions for inmates presenting mental health issues.
- 9. Develop medical care plans.
- 10. Maintain medication administration records.
- 11. Ability to take calls, rotate shift, work weekends as necessary or holidays as assigned to assure medical coverage.
- 12. Performs health assessments and screening procedures.
- 13. Maintains comprehensive, quality records, reports and professional correspondence.
- 14. Performs other duties as assigned.

REQUIREMENTS:

Must be currently licensed as a Registered Nurse with the State of Texas. 2 years progressively responsible medical/surgical experience. Correctional health experience preferred. Must be able to successfully complete background investigation and oral board examination.
